**II. Content**

Recall that a position paper typically consists of three paragraphs:

Paragraph 1: Introduction and Background Information. Briefly describe the situation and cite any relevant statistics you have found. Cite any previous actions the UN has taken regarding the issue and their outcomes.

Paragraph 2: Detailed Information and Country Stance. Clearly state your country's stance on the issue and justify it. Cite any previous actions your country has taken regarding the issue and their outcomes. Cite any relevant statistics specific to your country's involvement with the issue.

Paragraph 3: Proposed Solutions Regarding the Issue. List your solutions to the problems you identified in the previous paragraph. Describe how you would feasibly implement each of your proposals. Identify the global impacts of your proposed solutions.

**III. Outlining a Position Paper**

*Instructions: Using the paragraph of information provided below, outline a position paper on the topic of International Preparedness for Disaster and Prevention from the position of India.*

In an era of climate change, countries without national disaster prevention plans will find their cities and municipalities repeatedly engulfed by disasters. The 1976 earthquake which hit Tangshan, China, killed 242,000, leveling a city of one million people. The 2010 earthquake which struck Haiti killed more than 230,000 people and construction and recovery efforts are estimated to have cost \$14 billion dollars. India, a strong supporter of UN Resolution 3434 – which provided for an international funding framework for countries suffering from natural disasters – understands the plight of countries struggling to rebuild after major disasters. India sees the value of the Hyogo Framework for Action and of the Global Platform for Disaster Risk Reduction. Strengthening the capacity of local government units to address disaster risks and hazards is a major component of India’s strategy for disaster resilience. A national plan, no matter how good, will remain ineffective if not translated into local plans and action. It is necessary to empower local authorities to take risk reduction measures and incorporate disaster risk reduction into local government budgets.
